INFORMATION ABOUT THE SERVICE

Your Taalk Unlimited plan is for a home telephone service that gives you line rental and a telephone number which enables you to make and receive calls.

Minimum Term

1 Month

What's Included

Your Taalk Unlimited home phone plan includes home phone like rental and a telephone number. Your plan also comes with unlimited calls to standard local, national & Australian mobile calls.

What's Not Included

Your plan does not include calls to 13/1300 numbers and any international calls. Charges to these services will apply and are outlined below

INFORMATION ABOUT PRICING

Your Minimum Monthly Charge - \$65

Your Minimum Total Charge

\$65 –Your monthly usage will be charged at the rates below and will be billed according to your billing cycle.

No Early Termination Charges Apply

Because aaNet home phone services are month-to-month there are no early termination charges.

The total minimum amount that you will pay over the period of your plan term is \$65 if on a one (1) month contract.

Connection Timeframes

Once we've accepted your application, we'll try to connect your home phone service on the date you ask for, but this might not always be possible. If there has been a previous working home phone service at your property and we can reconnect it without having to visit your property, the local telephone exchange or anywhere in between. If this isn't possible, then we aim to connect your service within 5 to 15 working days, depending on your location.

Billing

The figures in this critical information summary are for a full billing cycle but your first bill may include some pro-rata charges for part of the month if you started or changed your plan part way through a billing period. On the same day each month you will be billed in for minimum monthly charge as well as any additional usage during this billing period.
